What does Charge Account vs. Credit Account mean?

<u>CHARGE ACCOUNT</u>: Charge Account can be Non-billable (will start with N, P or X in AiM for E&G customers) OR **Billable** (referenced in AiM as 10 digit SpeedType for CS departments, non-E&G customers, and E&G customers with SpeedType for items outside of service level agreement)

<u>CREDIT ACCOUNT</u>: OWNERSHIP SHOP in the AiM work order phase or DEPARTMENT that is charged in Emory Express. This is the number you will see in Emory Express (EE) as the charge account.

Note: In EMORY EXPRESS, the ownership shop or department is always charged when the PO transaction is generated. In AiM, the ownership shop or department is credited for the same Emory Express transaction, thus netting to \$0 for the ownership shop. The AiM work order Charge Account determines who bears the true cost (see above if billable or non-billable.)

Where do you find Charge Account and Credit Account Information in AiM?

<u>CHARGE ACCOUNT</u>: AiM / work order / contract phase / account setup / under "Charge"; Account: SmartKey = customer that is billed (could be Non-Billable or non-billable)

CREDIT ACCOUNT: work order / phase. Look at shop assigned.
